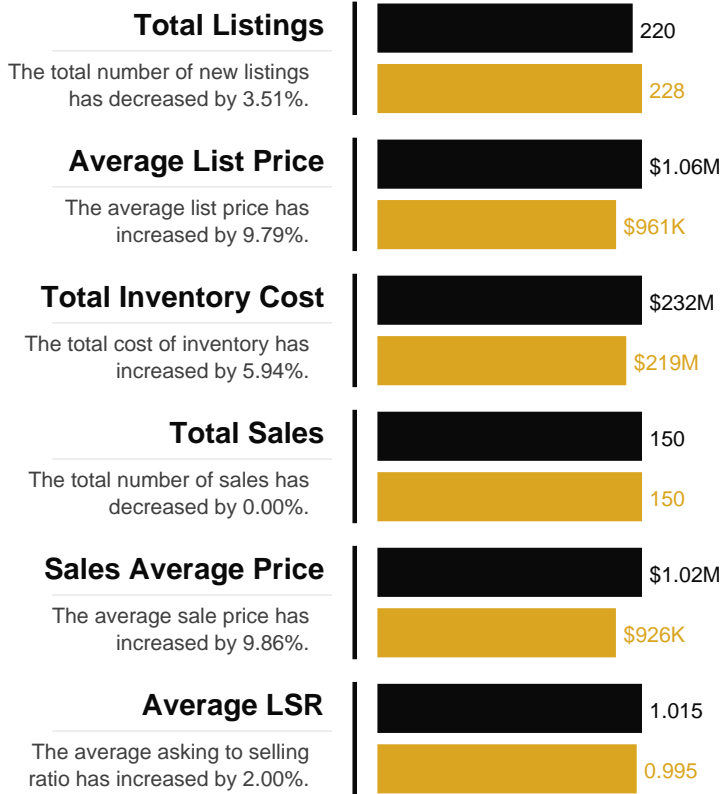

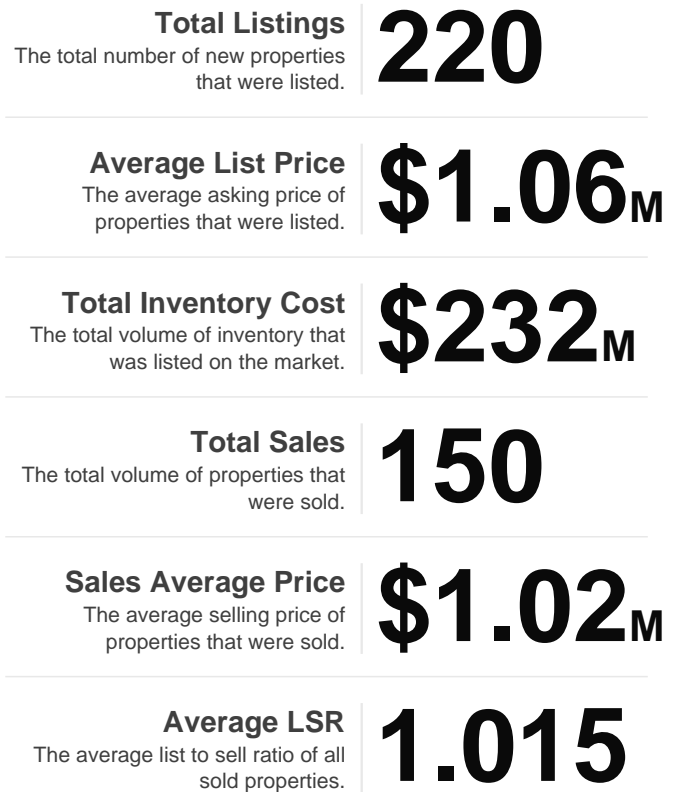
Below, we are comparing the year of 2020 to the year of 2019.

Average DOM

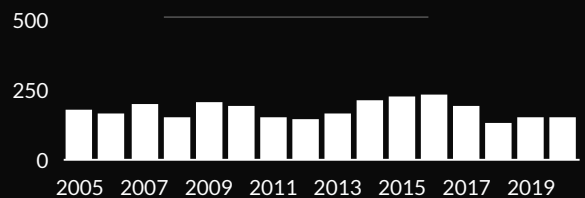

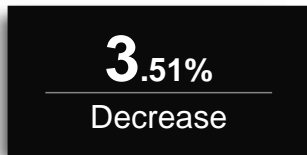

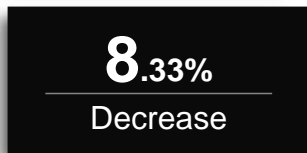
Total Listings

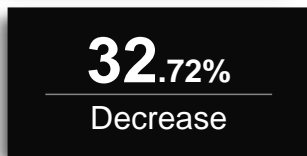

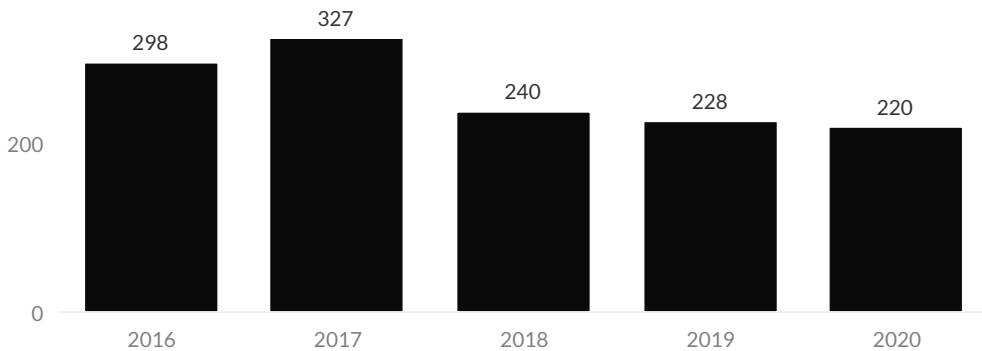

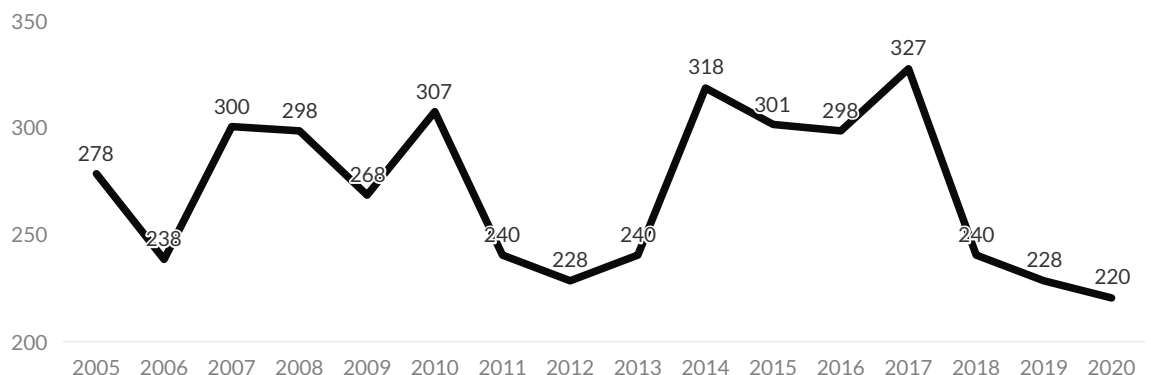

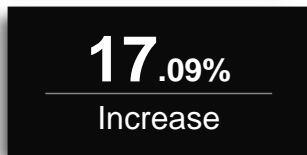
Average List Price

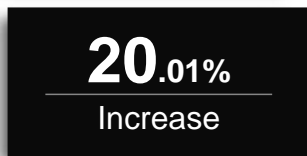

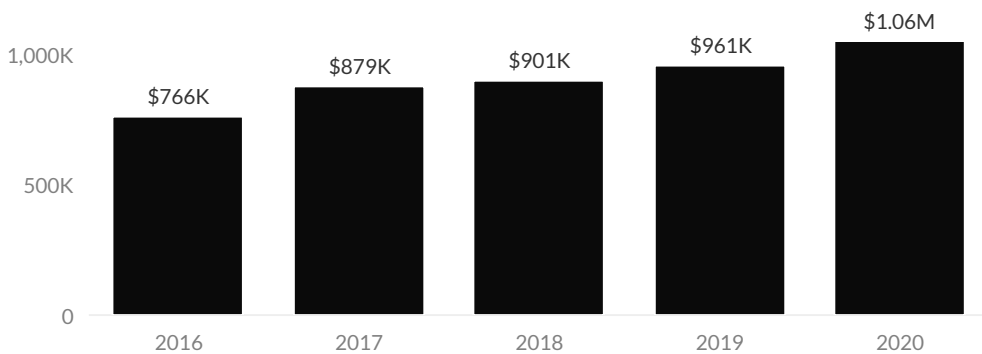

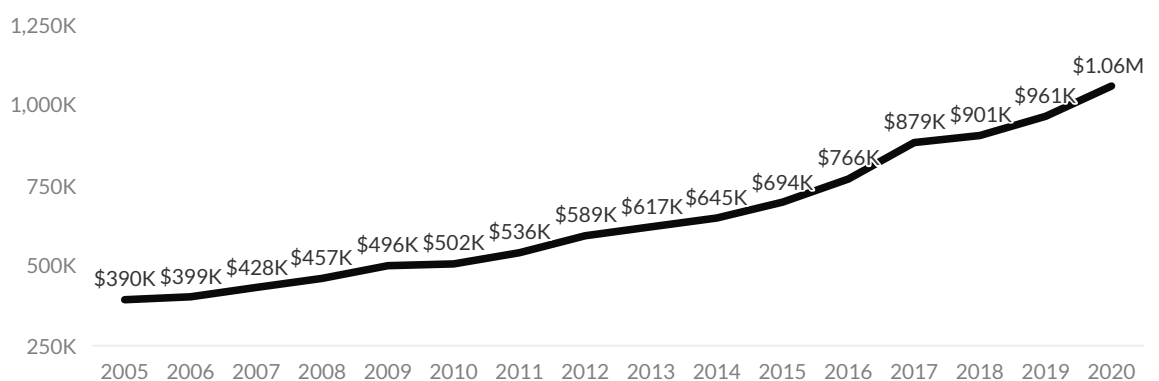

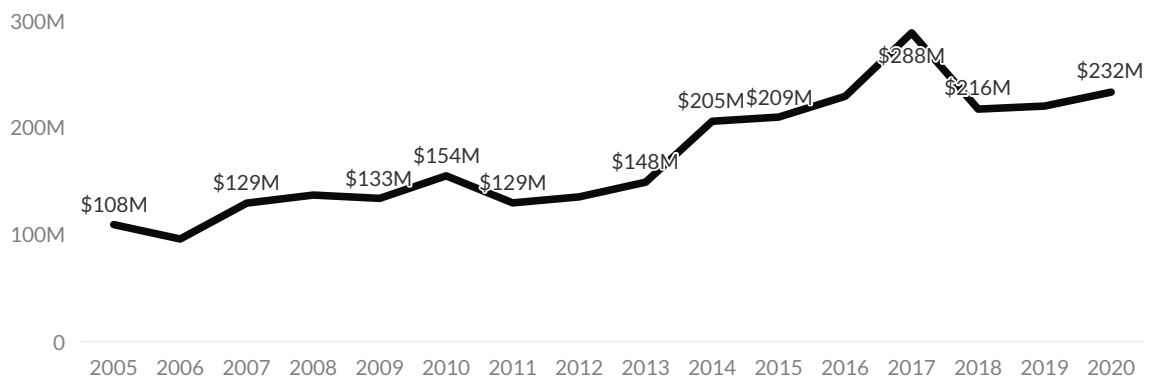

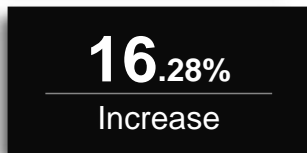

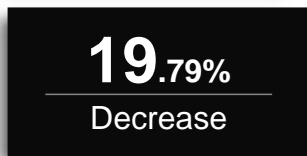

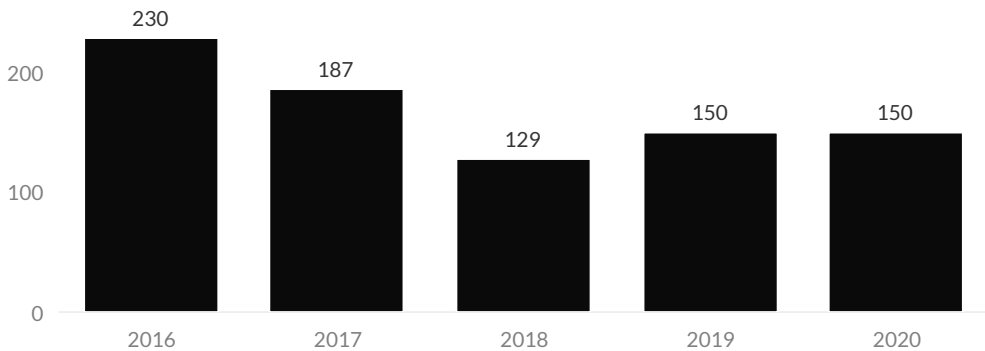

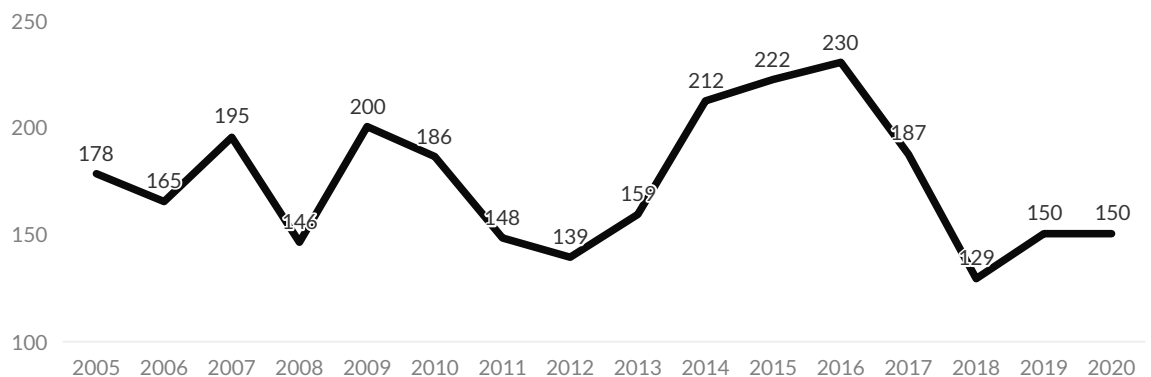

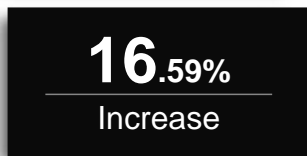

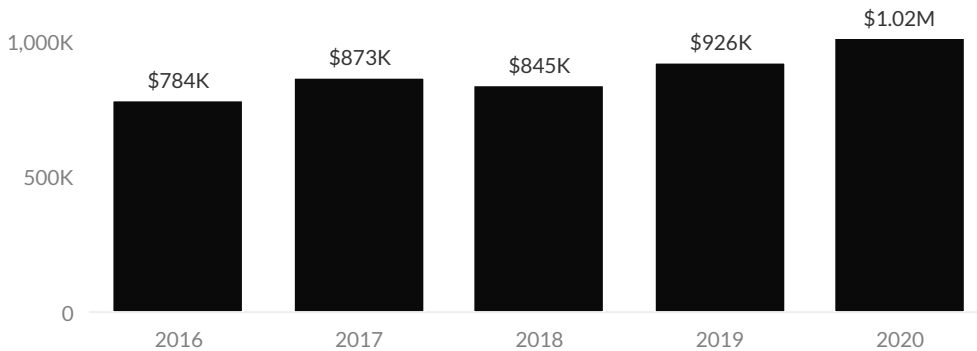

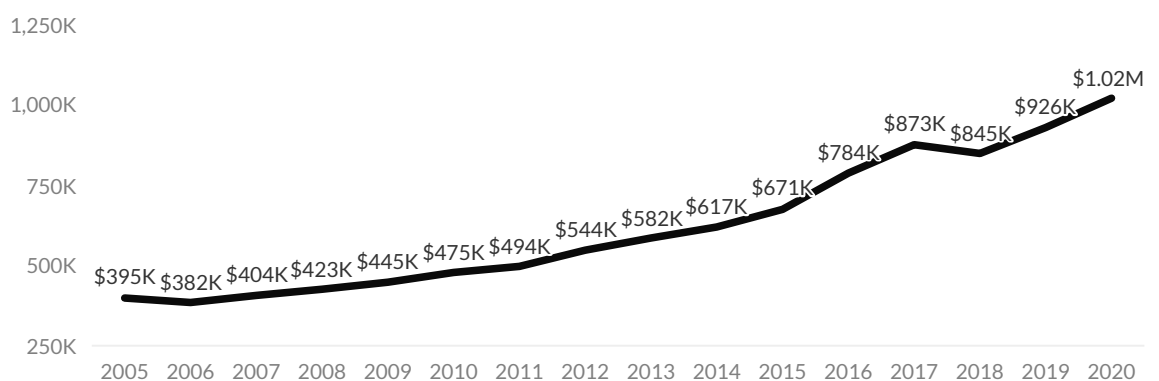

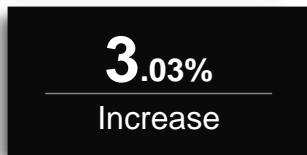

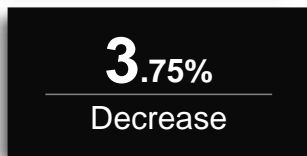

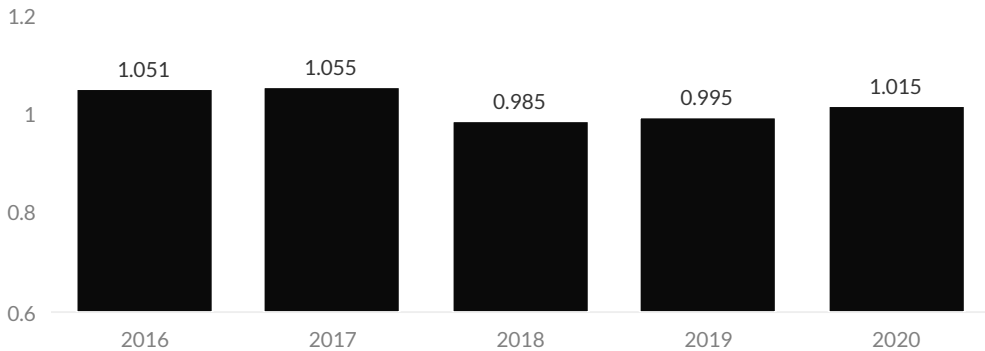

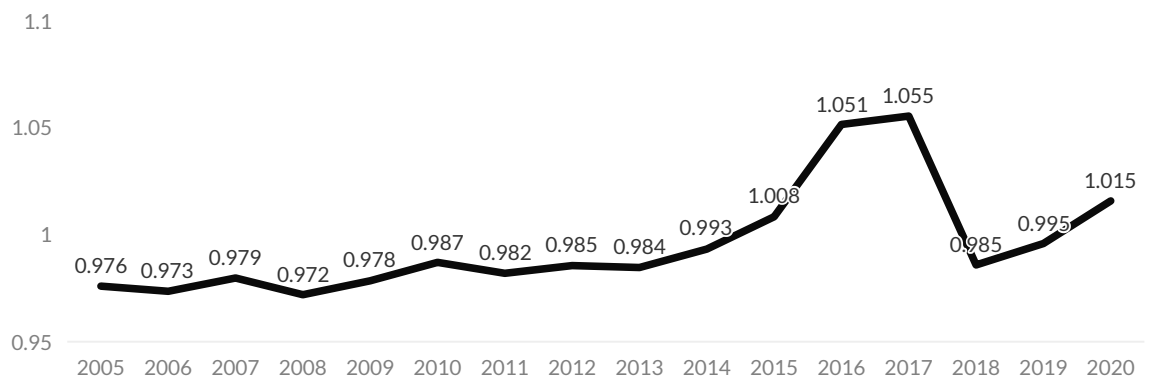

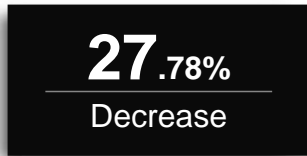

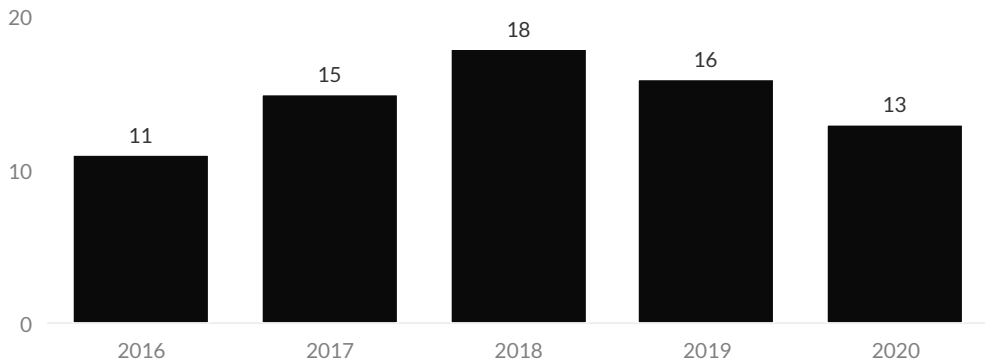

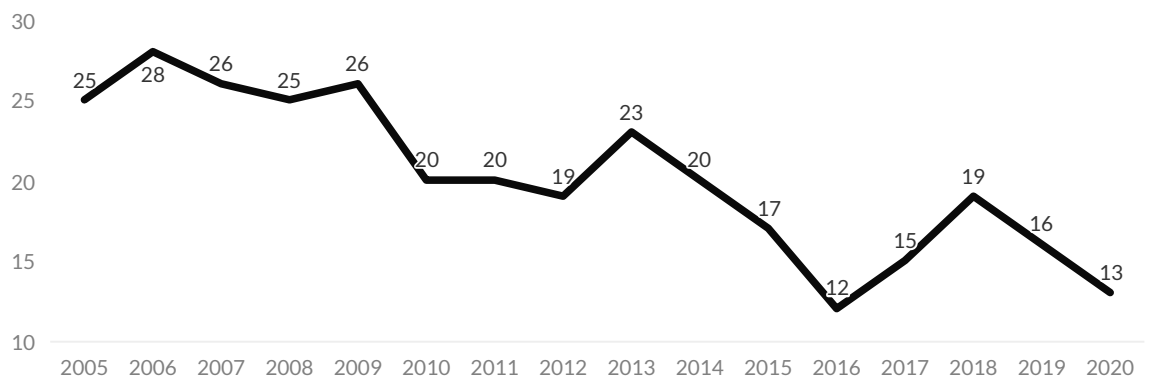

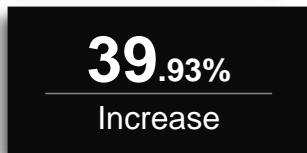

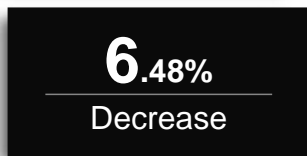

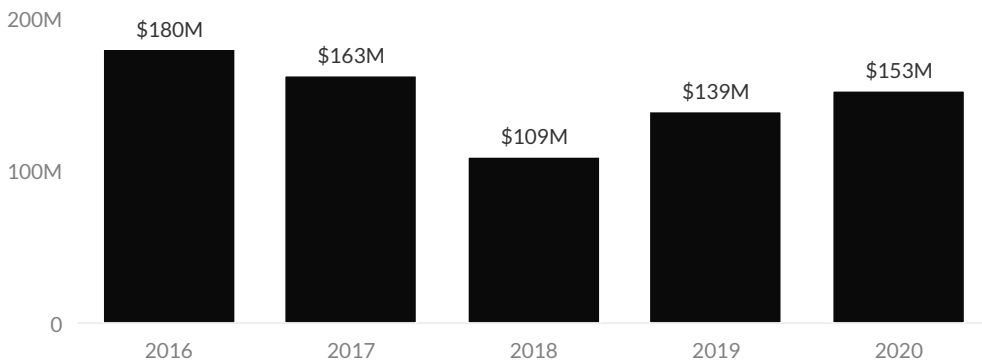
